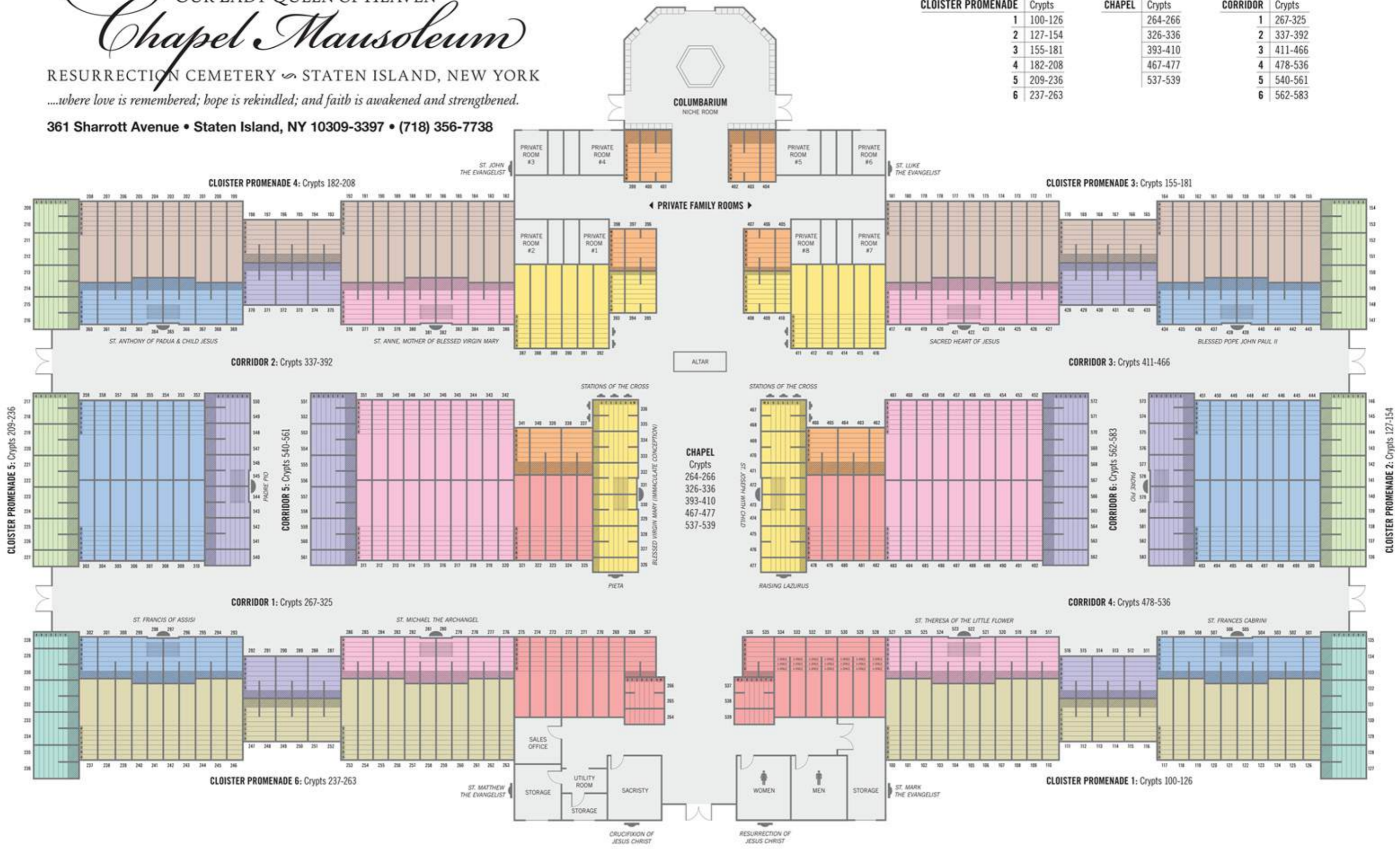

CRYPT ACCOMMODATION/ PROTECTION

1. Required caskets for this building are metal self-sealer. The maximum standard casket dimensions for accommodation in crypts at Our Lady Queen of Heaven Mausoleum are: 29" in width, 24" in height and 86" in length.
2. A limited number of oversize crypt spaces are available. Size limitations are: 33" in width, 24" in height and 86" in length.
3. For placement within any above-ground mausoleum crypt, human remains must be embalmed and placed in a metal self-sealer casket.
4. A casket protector, approved by the managing director of the Trustees of St. Patrick's Cathedral, is required for certain crypts and will be the usual and customary crypt liner. Casket protectors are available at no charge through the cemetery office at the time of entombment.
5. A full, hermetically-sealed casket protector is required for all disinterred caskets that are removed from the ground or transferred from another cemetery to any mausoleum crypt within Resurrection Cemetery. An order of the court is required for any disinterment or disentombment taking place within Resurrection Cemetery.

CHARGES FOR OPENING/SEALING CRYPTS

1. The charge for opening/sealing of the individual crypt space is collected at the time of each entombment.
2. The current posted charge for opening/sealing of a mausoleum crypt may be obtained from the cemetery office.

CRYPT COVER IDENTIFICATION

1. Inscription and perpetual care are included in the cost of the certificate of entombment rights for mausoleum crypts. Inscriptions typically take place following the first entombment.
2. All crypt fronts may have the given name, middle initial, and surname of the deceased; the year of birth and death, placed in uniform style in conformity to the other crypt fronts located in the same area. Professional, abbreviated designations following the surname are permitted.
3. All mausoleum crypts, with the exception of the family rooms, will be identified with incised lettering; this is lettering that is carved into the granite/marble.
4. Baptismal dignity requires the identification of any individual entombed or inurned, and if proper memorialization is not possible due to the corridor's common design identification, an inurnment of cremated remains will not take place within a crypt.

CAMEO PICTURES RELIGIOUS ART EMBLEMS

1. Religious emblems and military designations are permitted on mausoleum crypt fronts.
2. In order to preserve the uniform integrity and simple beauty of the mausoleum, such emblems and designations must be purchased through Resurrection Cemetery.
3. Cameo pictures, religious art and emblems are typically purchased after the first entombment and placed by the cemetery shortly thereafter.
4. The number of permitted emblems and/or military designations is based on the size of the crypt front and communicated at the time of purchase.

DECORATION REGULATIONS

1. Because this facility has both indoor and outdoor crypts, detailed floral regulations have been adopted and are provided at the time of purchase.
2. Under no circumstances may any item be glued, taped, or in any other way affixed directly to a crypt front or in the spaces between individual crypt covers. Such placements will be removed and disposed of immediately.
3. All wilted flowers or plants will be removed every Wednesday afternoon. All vases or ornamentations not approved by the cemetery, or located in any area outside of that designated by the cemetery, will be removed as identified.
4. The building's exterior landscape in the property of Resurrection Cemetery may not be altered in any way.

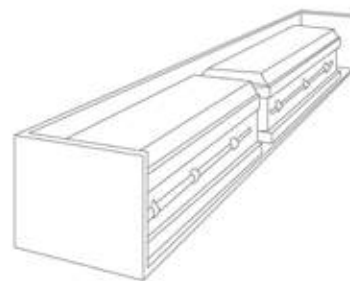
TEMPORARY ENTOMBMENTS

1. In the event a pre-need purchased entombment space is required prior to completion of construction of the building, the cemetery will make available a temporary receiving space until such time as transfer of the remains to the purchased proper crypt in the mausoleum can be made.
2. In the case of such pre-construction temporary entombments, the cemetery, at its cost and expense, shall have the absolute right to remove and entomb the remains in the crypt originally selected. Outer casket protection is required for such types of temporary entombment.

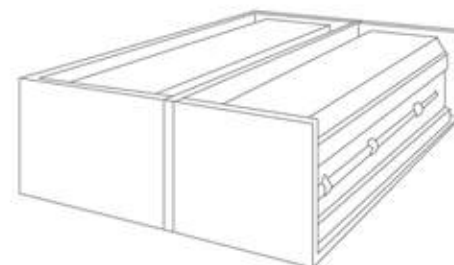
VISITATION/ACCESS DURING CONSTRUCTION

1. Funeral directors and cemetery management/office staff will facilitate and communicate arrangements for temporary entombments during construction and may limit the number of family members permitted at the temporary site to witness the temporary entombment.
2. Owners of entombment rights are requested and encouraged to communicate restricted visitation and decoration policies to extended family members and friends of the deceased so that any and all misunderstandings of policies and regulations are avoided.
3. Visitation of the temporary entombment site, because of on-going construction activity and other committal services, will be limited to weekday and weekend afternoons (after 2:00 PM) until the cemetery closes.
4. Floral tributes at temporary entombment sites will be strictly limited to cut flowers that may be placed at designated sites. All floral tributes, because of the construction and entombment activities, will be removed every Wednesday after 3:00 PM.
5. Other non-floral tributes as described above, will be removed immediately upon identification without any notification to the family placing such items.

Side-By-Side: Two Single Fronts



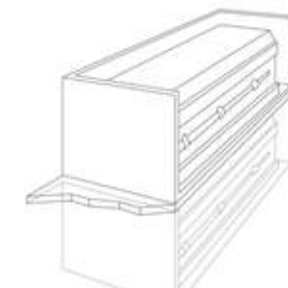
